Executive Officer's Report

RICHARD B. MOORE, PLS

October ... 2023! Where did this year go? From what we hear from members of the professions with whom we at the Board regularly communicate, it appears that many are asking the same question. Needless to say, this has been a very busy year for all.

Two years ago in the Fall 2021 edition, my message included the following:

In this edition, you will see that volumes for both applications and licenses issued are generally still reflecting a downward trend as a result of the disruption caused by the pandemic last year. Licensing numbers reflect that some disciplines of engineering are more popular than in years past while other engineering, land surveying, and geology licenses are either decreasing or holding relatively steady. We are all hoping that the 2021–22 numbers begin to trend back up as we all rebound from this historic event.

Well, that's what we get for hoping for upward trending numbers! While it is accurate to say that some of the Board's license types, namely Professional Land Surveyor, Professional Geophysicist, and most of the Title Act engineering branches are reflecting a slow decline of active licenses over the last decade, interest in Fire Protection Engineer has bucked that trend growing at a respectable 38.9% over the same timeframe. Interest in the Electrical Engineer license has shown the greatest growth (22.9%), in terms of percentage, while interest in the Mechanical Engineer license is reflecting a respectable growth in terms of both percentage (11.6%) as well as close to matching the actual active licenses (1,555) with Electrical Engineers (1,958).

And while the interest in the Civil Engineer license has shown a respectable growth of 11.2% with an actual increase in numbers of 5,640 active licenses over the same time period, the more recent and substantial increase in application volume for the Civil Engineer license is projecting to make an upward impact on future versions of the Board's licensing statistics. As reported at Board meetings and in recent editions of the Board *Bulletin*, we are experiencing a dramatic increase in initial application types which began



about mid-2022 and has appeared to peak earlier this year with a recent minor downward trend slowing down to levels which the Board had originally anticipated a few years ago.

Since this chart is only reflecting numbers through September 2023, the Board is closely monitoring these trends as we progress through the remainder of this year and into 2024.

Please take a few minutes to peruse the licensing and application information in this edition of the *Bulletin* as we believe you will continue to find this information thought provoking, especially for our readers who are licensed by this Board. Additionally, if you haven't already done so, I suggest you subscribe

Board News on NCEES Changes

The NCEES PE Structural Examination will transition to computer-based testing (CBT) in 2024. The NCEES website has updated examination information in detail regarding the transition and how the examination will now be formatted and administered.

Registration for the CBT PE Structural Exam opened on November 1, 2023. California applicants may now register and sit for the CBT PE Structural Exam *without* prior approval from BPELSG. Once an applicant has successfully passed both components of the exam (Vertical and Lateral), has the required qualifying experience, and has an active Civil Engineer license in California, they may apply for licensure as a Structural Engineer. There is no final filing date; applications can be submitted and will be accepted on a continuous basis.









Total Number of Licenses Issued Annually, Practice Acts - by Discipline







Total Number of Licenses Issued Annually, Title Acts—by Discipline




Average Number of Licenses Issued Annually—Practice Acts





Change in Numbers of Active Practice Act Licenses (2012–2023)















Enforcement Actions

Citations Issued to Unlicensed Individuals: Fiscal Year 2022–23 (April–June)

Citations are an alternative to criminal prosecutions that the Board can use to enforce the laws prohibiting the unlicensed practice of engineering, land surveying, geology, and geophysics, or other activities for which a license is required. When a fine is levied with a citation, payment of the fine does not constitute admission of any violations charged but represents a satisfactory resolution of the matter pursuant to Business and Professions Code Section 125.9(d). Code sections numbered in the 6700s, 7800s, and 8700s refer to the Business and Professions Code; those numbered in the 400s and 3000s refer to Title 16 of the California Code of Regulations. You may look up the code sections and read the laws on the Board's website, **www.bpelsg.ca.gov/laws/index.shtml**. All final citations are matters of public record.
